Carroll County IDA Draft Meeting Minutes November 5, 2018

The Carroll County Industrial Development Authority held its regular monthly meeting on Monday, Nov. 5, 2018 at the Carroll County Governmental Complex in Hillsville.

Minutes

Mr. Wilson made the motion to approve the minutes of the Oct. 1, 2018 meeting as submitted. Mr. Edwards seconded the motion, which was approved by a 7-0 vote.
