Dear Ms. Burton.

Carroll County is holding \$16,722.16 for the sale of assets associated with the dissolution of Dugspur Rescue Squad. According to Articles of Incorporation of Dugspur Rescue Squad, Inc., "the remaining assets, income and profits of the corporation, over and above those necessary to pay debts and interest, shall be distributed to qualified charities under the Internal Revenue laws or to the governing body of Carroll County, Virginia, as determined by the members of the Board of Directors of this corporation."

While there was a Certificate of Restatement issued by the State Corporation Commission submitted to the County, this document does not provide a qualifying status. Once Dugspur Community Center provides a letter from the Internal Revenue Service demonstrating non-profit or qualified charitable status, the County will disperse the funds accordingly.
