I currently am licensed as a Qualified Mental Health Professional (Adult) in the State of Virginia. I have a strong grasp on the function, necessity and service provision of Community Services Boards, and particularly with Mount Rogers CSB. I understand the state mandate for CSBs and their expected and very helpful roles in our community. I was employed at Mount Rogers Community Services Board from 2006-2008 and have worked in coordination with their programs in years since, as well in coordination with programs at various other CSBs around the state, which has increased my knowledge about their services. I am not an employee of the CSB and have not worked there directly or contractually since February 2008. My current positions (contractually with Wall Residences as a Sponsored Residential Provider or as a Therapeutic Options instructor) in no way conflict with serving on this board, as Mount Rogers CSB is not a regulatory, oversight or investigative body for the services I provide and I do not profit from their services.

From Case Management to Mental Health Supports, from Skill Building Aides to Community Engagement, Sponsored Residential, Crisis Services, In-home, Respite, etc. I am intimately familiar with the services they provide and their importance to our community. I have strong knowledge of their funding sources, regulatory bodies (Department of Medical Assistance Services, Department of Health and Developmental Services, OSHA, Labor Laws (as they apply to the Direct Support Professional positions within Mt. Rogers CSB's services), Office of Human Rights, and Office of Licensing. My years of experience working in the field will allow me to contribute insight and uniquely allows me to be a strong ally for Mount Rogers Community Services Board. Specifically, I've served as a Regional Program Manager for Sponsored Residential Homes (Adult Foster Care) in Southwest Virginia (2008-2010), as a Community Engagement Program Manager for people with disabilities (also with Wall Residences) from 2017-
