The Virginia Sheriffs' Association has some good news to share; Senator Janet Howell's **SB 149** regarding an increase in sheriff's fees has been signed into law.

Governor Northam has signed **SB 149**, which allows localities to increase Courthouse and Courtroom security fees to \$20.00. Most localities have already passed ordinances authorizing a \$10.00 fee.

Sheriffs should contact their local governments to discuss increasing the fee up to \$20.00. If enabled, fees from this bill may generate \$13 million for sheriffs.

Site Assessment

December 20, 2017

Tank #1 – Facility ID # I-025501 - located at 116 Franklin Street, Hillsville, Virginia is owned and maintained by Carroll County. The tank was previously owned by the Carroll County School Board. The gasoline tank was installed on July 1, 1990. The tank is a 5,000-gallon fiberglass reinforced plastic tank. The piping is safe suction with no check valve at the tank. Release detection methods being used are tightness testing and vapor monitoring. To contain spills and prevent overflows there is an overflow ball float valve.

The material used to backfill the tank is gravel which readily allows diffusion of vapors from releases into the excavation area. Gasoline is contained in the tank so vapor testing is appropriate. This site is suitable for vapor monitoring as described in 9VAC25-580-160.5.f and 160.6.g.



Revised Site Assessment from 12-20-17

During the 12-17-19 DEQ inspection we found that to contain spills and prevent overflows an automatic shut off was installed sometime between 2009-11 instead of using the ball float valve which was the method when the tank was installed in 1990.

According to the drawings by Dewberry & Davis dated 4-23-1990 the monitors were installed same time the tank was placed.

RE: Groundwater Monitoring and Vapor Monitoring release detection methods changes

Dear Sir or Madam:

According to Department of Environmental Quality (DEQ) underground storage tank (UST) records your facility may be performing release detection using groundwater or vapor monitoring. *Please disregard this notice if you are using a different UST release detection method.*

Virginia's UST regulations will change effective January 1, 2018. One of the changes applies to facilities using this release detection method.

Current Requirement:	New Requirement:
Any person <i>with sufficient knowledge of the UST facility site and its relevant geology to properly address the regulatory criteria</i> may perform a site assessment to demonstrate that the facility site is suitable for using vapor or groundwater monitoring as a leak detection method. The regulatory criteria are described in 9VAC25-580-160.5.f and 160.6.g of the regulations. You can access the relevant language by following this link: https://law.lis.virginia.gov/admincode/title9/agency25/chapter580/section160 .	Site suitability assessments done after January 1, 2018 must be certified by a professional engineer (PE) or certified professional geologist (CPG). Beginning January 1, 2021, DEQ will request a copy of your facility's site suitability assessment during the inspection process.

If you have a site suitability assessment in your facility file now, this change will not affect you. If you do not have a site suitability assessment in your facility file, any site assessment obtained after January 1, 2018 must be certified by a professional such as a PE or

Carroll County Board of Supervisors and the DEQ, Southwest Regional Office, agree that:

By July 31, 2020, Carroll County Board of Supervisors shall remove the tank located at the facility and submit a site closure assessment. If the decision is made to not remove the tank, a site assessment for vapor monitoring, signed by a professional engineer or geologist, must be completed by the deadline above in order to continue with the vapor

monitoring method of leak detection. Please submit documents to the attention of Courtney Brummitt, Petroleum Compliance Inspector, at the Southwest Regional Office.

DEQ expects that all of these items will be completed according to the schedule set forth in this agreement. Carroll County Board of Supervisors understands that failure to take the above-mentioned actions in accordance with the terms of this Agreement, may result in the DEQ Southwest Regional Office initiating enforcement action that may include imposition of a civil charge, including recovery of the economic benefit of non-compliance, and/or UST delivery prohibition.

Site Assessment Requirements

(If conducted after 1/1/18, must be signed by professional engineer or geologist.)

5. Vapor monitoring. Testing or monitoring for vapors within the soil gas of the excavation zone must meet the following requirements:

a. The materials used as backfill are sufficiently porous (e.g., gravel, sand, crushed rock) to readily allow diffusion of vapors from releases into the excavation area;

b. The stored regulated substance, or a tracer compound placed in the tank system, is sufficiently volatile (e.g., gasoline) to result in a vapor level that is detectable by the monitoring devices located in the excavation zone in the event of a release from the tank;

c. The measurement of vapors by the monitoring device is not rendered inoperative by the groundwater, rainfall, or soil moisture or other known interferences so that a release could go undetected for more than 30 days;

d. The level of background contamination in the excavation zone will not interfere with the method used to detect releases from the tank;

e. The vapor monitors are designed and operated to detect any significant increase in concentration above background of the regulated substance stored in the tank system, a component or components of that substance, or a tracer compound placed in the tank system;

f. In the UST excavation zone, the site is assessed to ensure compliance with the requirements in subdivisions a through d of this subdivision 5 and to establish the number and positioning of monitoring wells that will detect releases within the excavation zone from any portion of the tank that routinely contains product; and

g. Monitoring wells are clearly marked and secured to avoid unauthorized access and tampering.
