

## NOTICE OF PUBLIC HEARING PROPOSED COUNTY BUDGET FOR FISCAL YEAR 2020-2021 PROPOSED TAX LEVY FOR CALENDAR YEAR 20 CARROLL COUNTY, VIRGINIA

Pursuant to Section 15.2-2506 of the <u>Code of Virginia</u> and amendments thereto, the Carroll County Board of Supervisors will conduct a public hearing. The purpose of the public hearing is to give the citizens of Carroll County an opportunity to comment on the proposed County Budget (which includes the School Board Budget) for Fiscal Year 2020-2021 and the tax levy for Calendar Year 2020.

The public hearing will be held on Monday, June 22, 2020, in the Board Room of the Carroll County Governmental Complex, 605-1 Pine Street, Hillsville, Virginia, at 6:00 p.m. or as soon thereafter as practical. Due to teh public health threat posed by COVID 19, current guidance by the Governor of Virginia on social distancing and public gatherings, the meeting will occur via electronic means or if by physical attendance the in-person gathering size shall be limited to ten (10 individuals, including board members and staff. The meeting will be streamed live via internet and any Carroll County citizen wishing to speak can send comments to crystal.adams@carrollcountyva.gov, mail comments to 605-1 Pine Street, Hillsville, VA 24343 or call 276-730-3001 and provide a telephone number to be called during the meeting. All comments will be entered into the official minutes of the Carroll County Board of Supervisors Meeting.

The inclusion in the budget of any item or items **DOES NOT** constitute an obligation on the part of the Board of Supervisors of Carroll County to appropriate any funds for that item or purpose. There is no allocation or designation of any funds of this County for any purpose until there has been an appropriation for that purpose by the Carroll County Board of Supervisors.

The budget has been prepared on the basis of the estimates and requests submitted to the Board of Supervisors by the Constitutional officers, intergovernmental agencies, non-governmental agencies and department heads of Carroll County and review and amendments to those requests by the Board of Supervisors and staff.
